(4) If the boat bears registration number or has been registered with any state including Kansas, insert the number. **If the boat has an existing Kansas number, please include the previous owner's certificate of number or a letter stating boat was sold, when application is remitted to Pratt.** (5) Insert Hull Identification number. All boats manufactured after November 1972 are required by Federal law to have a 12 digit Hull ID #. (6) Insert boat make and model. If boat was built by owner or builder is unknown, please specify. (7) Insert Model year. (8) Insert length of boat in feet. Drop the inches. Do not round off to the next foot. (9 - 14) Mark appropriate box. (15) Insert appropriate information on motor and trailer. If unknown leave blank. (16) Insert horsepower rating from the boat capacity plate. These plates were not required before 1972. If unknown, leave blank. (17) Toilet: mark appropriate box. (18) Enter the date the boat was purchased. (19) Fill in where the boat was purchased. **If the boat was purchased from a KANSAS DEALER submit with a form STD8 or bill of sale showing sales tax paid.
